Z92.7'S "RICKEY SMILEY TICKETS" CONTEST OFFICIAL RULES

The Station will conduct the **Z92.7's "Rickey Smiley Tickets"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. <u>Text</u>: Send a text message with the keyword "FUNNY" spelled correctly to 810-767-9300 during the Contest Period. All entries must be received by 11:55 PM on April 6, 2025 to be eligible for a chance to win a prize for contest entry period. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

Texting will not increase an entrant's chances of winning. Limit one (1) entry per person per day, regardless of the method of entry chosen by a listener. Each day of the Contest, listeners may either (i) text in an entry into using a mobile device or (ii) enter online, but not both methods.

4. **Winner Selection.** On or about 11:00 am ET on April 7, 2025, Station will select one (1) potential winners in a random drawing from among all valid entries received by Station during the Contest Period. Station will select one (1) potential winners in a random drawing from among all valid entries received by Station during the Contest Period #2. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and
